

OFS Artificial Intelligence and Data Science Scholarship 2023/24

Terms and Conditions

What is the Artificial Intelligence and Data Science Scholarship?

The University of East London (UEL) are offering a limited number of scholarships worth £10,000, under an OfS funded scholarship scheme, to successful applicants who accepted the "Conditional" or "Unconditional" full-time study offer letter for the MSc in AI and Data Science. This scholarship aims to support students from underrepresented groups.

1. Applicants will only be eligible to apply for an award if they meet all the following criteria:
 - Starting the MSc in AI and Data Science in September 2023 or January 2024
 - Studying full-time on campus
 - Fee assessed by our admissions team as a Home fee status
 - Students from the following underrepresented groups, with priority given to the first four groups. You must meet at least one of the below criteria below and are able to prove the same with supporting documents:
 - Female
 - Black
 - Disabled
 - Low-income background (Index of Multiple Disadvantage quintiles 1 and 2, low household income)
 - Care experienced.
 - Estranged
 - Gypsy, Roma and Traveller
 - Refugee
 - Children from military families, veterans, and partners of military personnel
2. Applicants who do not meet the above criteria are ineligible and will not be considered for an award.
3. Applicants with a previous STEM degree / equivalent are ineligible for this scholarship.

Application process

4. An application form is available on our website. Decisions are based on the quality of the student's application and if they meet the eligibility criteria as stipulated. Applications will be assessed internally by a relevant member of staff. All decisions are final and awarded on a first come basis until funds are exhausted.
5. The University will notify successful applicants of the provisional outcome via email. Scholarships will only be confirmed once an unconditional offer is issued by our admissions team. All other communications will be sent by email.
6. There are a limited number of scholarships available. The University is under no obligation to award all scholarships, should the quality of the applications be insufficient and who do meet the eligibility criteria.
7. Applications received after the deadline will not be considered.
8. Due to the large number of scholarship applications received annually, we are unable to offer individual feedback to unsuccessful applicants.

Payment details

9. Successful applicants will receive a £10,000 scholarship, payable after the student has completed the full enrolment process at UEL. Students have the option to choose a tuition fee waiver or receive the payment as a cash award. Payment will be made in three instalments, October 2023, January 2024, and March 2024.
10. The tuition fees for this course are £10,320.00. If student opts for a fee waiver, they can arrange a payment plan for the remaining £320 in order to finalise their enrolment. Students must contact the credit control team to set up a payment plan. Please email creditcontrol@uel.ac.uk
11. To receive the payment if you have opted for a cash award, student must upload their bank details to UEL Direct once they have enrolled.

General terms and conditions

12. The scholarship is only valid for the normal duration of the course, it will not be renewed or extended beyond this term to cover repeat modules.
13. If an awarded student decides to change programmes, the student will not be entitled to keep the scholarship and no further payments will be made.
14. If an awarded student decides to withdraw, the scholarship will terminate at the date of withdrawal. The scholarship may be reversed. UEL Fee liability dates within the tuition fee policy will apply.
15. The scholarship cannot be exchanged for an alternative award.
16. Once a period of study has commenced, should a scholarship holder suspend their studies through the proper channels, their scholarship is similarly suspended and will be recommenced on the resumption of studies. This can be held for a maximum of one year, starting from the date of their suspension.
17. If the student's status changes during their study, as a result of information not being provided at the point of application, and the student becomes ineligible, the University reserves the right to revoke the scholarship and claim back any fee waiver incorrectly made to the student.
18. If a student breaks the University regulations and is withdrawn from study, the scholarship will be immediately terminated, and no further support will be available. If the student returns to study at a later date, the scholarship will not be re-awarded.
19. Students who are awarded a scholarship must commit to support the University with future promotion of UEL through ambassadorial works, and a minimum of 4 events, such as open days and open evenings. This will be the equivalent of ten hours unpaid work for the university. Successful students will also need to commit to a photo, testimonial profile and video testimonial promoting UEL as a minimum.
20. The University reserves the right to verify applications and request additional evidence.
21. A complaint is normally a specific concern related to a procedural error, irregularity, or maladministration in admissions procedures or policies. If you
