## Course Aims and Learning Outcomes

This course is designed to give you the opportunity to:

- Develop an advanced independent performing arts practice and area of research, realized within a professional context.
- Analyse current models of artistic practice relevant to the research area
- Elaborate a theoretical / critical framework for the research that informs and supports creative practice
- Establish an advanced professional practice that makes connections between intention, process, outcome, context and methods of dissemination and production.

What you will learn:

### Knowledge

- To establish and analyse a methodology of creative practice research
- To understand the professional context within which you are working
- To work flexibly and imaginatively with the key literature and critical approaches of your research area

### Thinking skills

- To demonstrate an analytical approach to performance practice
- To link creative practice with professional practice and theory
- To reflect on learning through advanced and sustained research
- To make use of critical response from audiences to work in progress

### Subject-Based Practical skills

- To develop the technical skills appropriate to your form and discipline of creative practice
- To critically reflect on performance practice and its process
- To keep a reflective journal of research
- To undertake a literature review and map performance context and use creatively in practice
- To work collaboratively to develop and produce performance practice

## Research/project work

Registration of proposal happens within 6 months of enrolment (full time) or 12 months of enrolment (part time) and is backdated to enrolment date.

Supervisors are negotiated according to student's research area.

Ethics is considered by the student and supervisors and ethical approval is applied for if relevant, at the time of registration or subsequently.

Viva examination takes place after 3 years (full time) or 5 years (part-time). The viva exhibition is the thesis to be examined, supported by a 15,000-20,000 word report.

## Course Structure

All courses are credit-rated to help you to understand the amount and level of study that is needed.

One credit is equal to 10 hours of directed study time (this includes everything you do e.g. lecture, seminar and private study).

Credits are assigned to one of 6 levels:

- 3 Equivalent in standard to GCE 'A' level and is intended to prepare students for year one of an undergraduate degree course.
- 4 Equivalent in standard to the first year of a full-time undergraduate degree course.
- 5 Equivalent in standard to the second year of a full-time undergraduate degree course.
- 6 Equivalent in standard to the third year of a full-time undergraduate degree course.
- 7 Equivalent in standard to a Masters degree.
- 8 Equivalent in standard to a Doctoral degree.

Courses are made up of modules that are each credit weighted.

### Typical Duration

Recommended:

Entrance fees and travel costs for attending performances this can vary but you should budget around £250 per year).
