The Research Excellence PhD Studentships are the premier postgraduate merit studentship at UEL and provide full tuition fees and a generous stipend.

The School of Arts and Creative Industries

The research will be hosted by UEL's School of Arts and Creative Industries (ACI) within the department of Performing Arts.

Research students and staff in ACI are active in areas ranging from film studies to cultural theory, the performing arts, and art and design. Our research is embedded in our East London location and issues of diversity and marginalisation, cultural and social regeneration, social justice and community cohesion, are central themes. Both in scholarly publications and creative practice research, we aim to question and illuminate, and to engage students and the wider community as well as academic staff in the excitement of discovery and debate.

About the Studentship:

Proposed Project Title: Creative Walking and Community Connection

Project Summary:

This research project will explore how creative walking practices can increase community connections and well-being. Building on previous research on walking and well-being, and in particular *The Walkbook: Recipes for walking & wellbeing* (2022), the project will engage diverse populations, including international students, home students, university staff and communities living and working in east London. The proposal should emphasize strong engagement with Newham, the specific approach the researcher plans to take and how that will generate significant impact in the community.

The University of East London spans three campuses in Newham, London, each offering different experiences of the borough and its relationship to greater London. Newham is a rapidly expanding borough with a diverse population. While the population mirrors that of the University in many ways, community integration remains a challenge, especially for transient student populations. Partnerships with the Walking Artists Network and The Line public art project in East London will support routes for the project to develop. The researcher will work closely with Clare Qualmann and Anna Minton whose combined expertise covers creative walking, the interface between architecture, democracy and the city, foregrounding the connections between people, place and politics.

Industry Partner: The Walking Artists Network, The Line

Research Context:

The University of East London (UEL) is spread out over three campuses in the London Borough of Newham. Each campus offers different experiences of the borough and its relationship to greater London. Newham is incredibly diverse and densely populated—in 2021 it was among the top 3% densest areas in England and its population is rising at a higher-than-average rate. In many ways its population mirrors the student population of UEL; this does not, however, always translate to integration with the community. Through the use of walking, and particularly creative walking practices, the project will explore the built environment of Newham and the campuses of the University of East London in relation to community connections and well-being for student, staff and local populations.

Working closely with Clare Qualmann (Associate Professor in Contemporary Performance), the researcher will be expected to develop a methodology for walking and community engagement, within the specific context of Newham and the campuses contained within it, in relation to questions around space and place. For example, how might walking engage transient student populations, often from international community diasporas, to respond to and engage with the specific community of Newham in which they are living and learning? Other students commute in from their home communities, creating a different engagement with the university and with Newham. How can these different students' needs for community engagement with the areas in which they are studying be addressed through creative walking methodologies? How might community neighbours connect with the life of the University and local public spaces?

The project will build on the underpinning research for *The Walkbook: Recipes for walking & wellbeing* (2022), which was created as part of the AHRC funded research project WalkCreate and provides artistic responses to barriers to walking. The research could be approached from a variety of perspectives, for example,

- walking and nature connection,
- walking and community.
- · walking and disability,
- walking and older people,
- walking and young people,
- walking and mental health,

The proposal should outline a clear link between east London, the researcher and the proposed research approach. Additionally, it should show a strong engagement with the neighbourhoods' diverse communities. While the research methodology does not need to be developed for the proposal, it should indicate how it will be developed in relation to the researcher's already existing research or practice. Essential to the project will be including the generation and tracking of Impact as part of the developed methodology.

Research Methods and Timeline

Year 1

- Desk-based research:
 - survey/review literature on creative walking methods
 - survey/review of how the Walkbook is being used, disseminated, etc.
 - survey/review of Newham based literature.
- Development of methodological framework and initial fieldwork
- Ethics process and review

Year 2

- Continued fieldwork: gathering and analysing data on current impact-evaluation practices, e.g., walks, workshops, interviews, focus groups, ethnographic observations;
- Continued desk-based research, analysis of comparable creative walking practices for wellbeing;
- Devising, implementing and evaluating new models using an iterative process of test pilots.

Year 3/4

- Write up, including the potential development of resources that can be used by stakeholders as a result of the research project.
- Expectation of 1 peer-reviewed publication, co-authored with a REF eligible employee (e.g., Clare Qualmann)
